



SCHOOL USER CODE OF CONDUCT

- 1. Verification of Eligibility and Background Checks.** Go Together is a platform provider only, and Your School, and not Go Together, determines the qualification and approval processes for your access to and use of the Services, and Your School is responsible for making all verifications in connection therewith. Your use of the Services and participation in Trips facilitated using the Services may be subject to you satisfactorily completing a background check screening performed by or on behalf of Your School, as determined by Your School. In some cases, pursuant to our agreement with a Partner School, Go Together may be responsible for engaging a third party background checking service provider that is approved by the Partner School ("**Background Check Service Provider**") to perform, on behalf of the Partner School, background checks on School Users associated with the Partner School. If Your School has such an agreement with Go Together, Go Together will facilitate the use of the Background Check Service Provider's services for you. Subject to Your School's policies, you may be responsible for the costs of performing any such background check (to determine whether you are required to undergo a background check and whether you will be responsible for any additional fees in connection therewith, check Your School's policies). If we facilitate any background check services for you at the direction of Your School, Go Together will not receive the results of your screening; rather, your background check report will be sent to Your School and you. If you wish to dispute anything in your report, you must work with the Background Check Service Provider directly.
- 2. Eligibility and Your Responsibility for Trips.** Go Together provides the Services for the purposes of assisting School Users in the planning, scheduling and participation in Trips. Only School Users who can form legally binding contracts under applicable law are eligible to use the Services to plan and participate in Trips. To participate in a Trip as a driver, the School User must also have a valid legal driver's license and sufficient legally required automobile insurance. As a condition of using the Services:

 - a.** You consent to have us provide Your information to Your School and to other School Users registered with Your School to help you find people to schedule and participate in one or more Trips.

- b.** You are solely responsible for evaluating, selecting and qualifying other School Users and their Students for participation in your Trips and for ensuring communication/arrangements with those School Users.
- c.** You are ultimately responsible for ensuring that all Trip arrangements have been clearly communicated. If for any reason you have concerns that there is confusion over an arrangement that has been made and/or you are not certain that one or more School Users participating in a Trip you have scheduled (or you have invited to participate in a Trip you have scheduled) has received alerts regarding the Trip, you should contact those School User(s) directly.
- d.** Go Together values our School Users and the larger community and requires that all School Users do their respective part as well. If you are a School User, you agree to the following:

 - i.** To the extent you are operating a vehicle for the Trip, you will at all times you are driving: (A) have a valid legal driver's license for the state in which you are driving, (B) have sufficient legally required automobile insurance for the state in which you are driving, (C) operate the vehicle in a safe manner and in accordance with all applicable motor vehicle, safety and other laws, and (D) use, and require all passengers to use, proper safety restraints (which at a minimum must be in compliance with applicable law for each passenger).
 - ii.** You shall not engage in inappropriate conduct (including, but not limited to, using inappropriate language, playing inappropriate music or content, smoking or texting while driving) at any time during the Trip (including, to the extent applicable, during pick up and drop off times).
 - iii.** You will at all times follow best practices and Your School's policies, if any, to mitigate to the extent reasonably possible the transmission of infectious illnesses, including coronavirus, during the Trip. Such practices will include, but are not limited to, sanitizing your hands prior to any Trip or in-person contact with any School User or Student participating in the Trip, appropriate use of face-masks (protect from and prevent spread of respiratory infections), cleaning and disinfecting commonly touched surfaces of the vehicle at the beginning and end of each Trip, and reporting any exposure or suspected exposure to a highly contagious disease.
 - iv.** You shall at all times comply with the requirements of the then-current version of the Go Together's School User Code of Conduct, located at <https://gottogether.today/go-together-school-user-code-of-conduct/> (the "**Code of Conduct**")
